#### OFFICE ORDER

In continuation of this office order of even number dated 03.08.2005 & 10.06.2009, Director, IARI is pleased to re-delegate the Financial powers to Joint Director (Research), Dean & Joint Director (Education), Joint Director (Extension) as per Annexure -I with immediate effect and until further orders:

## All the powers re-delegated will be subject to the terms & conditions given below:

- a Sanction shall not be accorded in favour of self. In case of Joint Director (Research), Dean & Joint Director (Education) and Joint Director (Extension), Director will have full power.
- b Availability of funds under appropriate head under sanctioned budget shall be ensured.
- c Fulfilment of prescribed procedures, terms and conditions laid down under GFR, delegation of financial power rules, ICAR Audit Manual/ FRSR and other rules/instructions/orders issued by GOI/ICAR/ Director, IARI from time to time.
- d Observance of economy instructions and restrictions imposed/issued by GOI/ICAR from time to time.
- e In respect of purchase to be made under PLAN for equipments/ photocopier, Computer etc. it has to be ensured before sanction that the items concerned are approved in the EFC Memo by the Council.
- f These powers shall be exercised only in respect of all staff members working in the Division / Units/ Regional Stations/ Centres etc. under the control of respective Joint Directors.
- g The proposals for sanction shall be routed through the respective section in Directorate viz. PCA, Stores, Personnel- 1,2,3, & 5 etc. And these sections will process the cases after keeping due records
- h While submitting cases to these sections, indenting officials will clearly mention under whom their division/ section is so that the cases are placed for sanction to the respective joint Directors
- i IN case of any difficulty in implementation etc, the matter may be brought to the notice of IMC Section for further processing.
